

Privacy Policy

Australian Museum of Design Pty Ltd (ACN 657 179 916) respects your privacy and is committed to its protection. We are bound by the Australian Privacy Principals of the Privacy Act 1988(Cth).

This privacy policy explains why and when we collect your personal information, and what use we make of that information. The policy also explains where and why your information may be disclosed to third parties, and the security measures used by Australian Museum of Design to help protect your personal information.

Why and when Australian Museum of Design collects your information

Australian Museum of Design collects the information you give us online. The personal information Australian Museum of Design will collect from you is the personal information required in order to provide you with promotional information, offers and promotions, and marketing material on behalf of other third party businesses. This information includes any of the following; your first name, last name, mailing address, phone number, email address, profile information and lifestyle information.

Australian Museum of Design may make limited use of cookies on campaign microsites. A cookie is a small message given to your web browser by our web server in order to store information about user preferences. We use cookies to provide information on our product offerings through content networks across the internet, to track your interaction with the microsites we build and to personalise your experience. You always have the option to disable cookies by turning them off in your browser but you may find that this reduces the functionality of microsites.

How Australian Museum of Design uses your information

We collect and use your personal information to deliver promotional information, offers and promotions, and marketing material on behalf of other third party businesses.

As a database and marketing company, we are required to make available the personal information we collect from you when you apply to receive it.

The personal information that Australian Museum of Design holds is not provided to any third company partner for use in email communication. All email correspondence delivered to you on behalf of a third party company will be done so via Australian Museum of Design (except where you have chosen to opt our of receiving this information from us).

If you do not wish to receive any marketing communications from Australian Museum of Design on behalf of third party businesses, you may opt-out and stop the delivery of future promotional material from Australian Museum of Design by following the special instructions in the email you receive. These instructions will tell you how to remove your name from our promotional list.

If you believe that Australian Museum of Design may hold other personal information about you which is inaccurate, or you wish to change or update any of the personal information you have provided, please contact us and we will amend it.

Security

The transfer of information across any media may involve a certain degree of risk, and the Internet is no different. However, helping you to keep your information secure is very important to Australian Museum of Design.

In order to protect the security of personal information transmitted to Australian Museum of Design online, our Web servers support the use of the Secure Socket Layer (SSL) Protocol where appropriate. Using this protocol, information transferred between our systems is encrypted.
